- Call Sheriff's office for Sale Date, all Foreclosure Sales are held in Room 262 on Thursday at 10:00 A.M. Sheriff's Sale forms can be found on our web site. MchenrySheriff.org Direct line to Civil Process is 815/334-4720
- Send <u>CERTIFIED COPY OF JUDGMENT</u> To Sheriff, we will then assign a Sheriff's number and open a Sale File. Certified copy must be sent to the Sheriff before publication starts.

#### At Time of Sale;

- 1. Present Original Certificate of Publication to Sheriff.
- 2. Present all the documents required, and copies please.
  - a) Foreclosure Estimate
  - b) Receipt of Sale
  - c) Sheriff's Report of Sale and Distribution (2 pages)
  - d) Original Certificate of Publication (2, 1 from R/E & 1 from Public Notice Section)
  - e) Certificate of Sale & **Duplicate** Certificate of Sale
- 3. Present check for Sheriff's Sale \$600.00 (EFFECTIVE 7/23/90 THERE IS A CANCELLATION CHARGE OF \$300.00 FOR ANY SALE CANCELED EXCEPT FOR THOSE CANCELED DUE TO BANKRUPTCY)

#### **AFTER SALE:**

- 1. Set Sale up for approval with Circuit Clerks office, (within ten days of sale)
- On the day set for approval, pick up signed documents at Sheriff's Office, have sale approved, return certified copy of of the Order Confirming signed or stamped with the Judge's name that approved the sale.
